


4. As an attorney not residing or practicing in Oregon, I am exempt from the Oregon State Bar Professional Liability fund plan requirements.

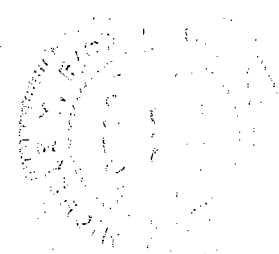

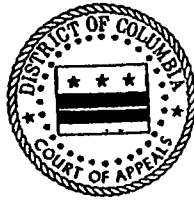


