OAR 860-027-0400(3) states, "An energy utility must file an IRP within two years of its

previous IRP acknowledgment order or as otherwise directed by the Commission." NW

Natural's last filed IRP was acknowledged in Order No. 12-161 issued in Docket No. LC 51 on

May 9, 2011. Division 27 rules require that the Company file its next IRP no later than May 9,
 2014.

In accordance with the waiver provisions provided in OAR 860-027-0000(2), NW Natural herein respectfully requests that its IRP due date be extended from May 9, 2014, to August 29, 2014, to allow NW Natural the additional time to perform further in-depth analysis of potential interstate pipeline alternatives. In particular, the Company will assess the Pacific Connector pipeline as an alternative. This will include analysis of the impacts the associated export LNG projects may have on prices and basis differentials, Jordan Cove for Pacific Connector and Oregon LNG for Washington Expansion. The Company will also provide an independent assessment of the reasonability of the cost and rate estimates received from the respective pipeline sponsors being used in the 2014 IRP analysis.

The Company has been working on its 2014 IRP since the first quarter of 2013 and has been speaking with interested parties about its work since August of 2013. To date, the Company has hosted six technical working meetings, has provided interested parties with a draft IRP, and has solicited comments on its draft. The comments received from Commission Staff, Citizens' Utility Board of Oregon ("CUB"), Washington Utilities and Transportation Commission ("WUTC") Staff, and Northwest Industrial Gas User ("NWIGU") consistently stated the Company needed to provide more analysis of other options to the Cross-Cascades pipeline.

At its April 3, 2014, technical working group meeting, the Company proposed filing its IRP by the May 9, 2014 due date and later filing a supplement that would include additional analysis of the other regional pipeline projects. Parties discussed this and in general, agreed that it would be preferable to have the Company seek an extended filing due date to allow all the analysis performed and an assessment of it to be included in the final IRP. Parties expressed concern with reviewing an IRP filed May 9, 2014, when the conclusions may change due to the additional analysis that would be provided a few months later.

On April 18, 2014, NW Natural emailed parties to present the proposal put forth in this Motion. No party objected to either extending the IRP filing due date to August 29, 2014, or to the scope of additional analysis that will be performed with the added time.

- 1 III. It was for the reasons stated above that NW Natural is requesting the Commission to
- 2 extend the IRP filing deadline from May 9, 2014, to August 29, 2014, and to request a waiver
- 3 from OAR 860-027-0400(3). The Company believes this request is beneficial to parties
- 4 participating in its 2014 IRP process and to the general public.
