Pursuant to OAR 860-001-0400(2)(b), the Citizens' Utility Board of Oregon (CUB), the Northwest Energy Coalition (NWEC), Renewable Northwest (RNW), and Industrial Customers of Northwest Utilities (ICNU) hereby file this Motion in Support of Sierra Club's request that the Commission review certain aspects of the General Protective Order in this docket. While all of the Intervenors have now signed (or will shortly sign) the General Protective Order in question, all have the same concerns with that protective order as those set forth by the Sierra Club in its December 17, 2014 Motion.²

As discussed by Sierra Club the Intervenors agree that:

- Publically Available Information can never be designated as confidential.
- There is a difference between unilaterally designated confidential information and actual confidential information and this difference should be spelled out in the protective orders.
- The Dispute Resolution Provision needs to be clarified. Is it limited or unlimited in terms of issues the ALJ can address.

² These concerns are not limited to the General Protective Order in LC 62 but the LC 62 docket is the docket in which clarification of these matters is most pressingly urgent. The Intervenors would like to see the same issues addressed for all dockets going forward.

- The term "use" should be clarified. Parties who have signed the protective order should be able to keep and use the information received under the protective order in related, and subsequent related, cases. As things stand counsel may maintain a copy of the information for counsel's use but an expert witness working with that counsel may not review the material. This limits the Intervenors ability to use the information in subsequent dockets. It would be much easier if both counsel and the expert witness were permitted to review the information kept by counsel and then draft appropriate data requests.
- The seven day waiting period for qualified persons should be reduced
- Qualified persons from different parties who have signed the protective order should be able to meet and discuss the protected information covered by that order.
