STAFF MOTION TO MODIFY
PROCEDURAL SCHEDULE

[Expedited Consideration Requested]

8 Pursuant to OAR 860-001-0420, Staff of the Public Utility Commission of Oregon (Staff)
9 moves to modify the procedural schedule for the three remaining events in this docket: Staff's
10 public meeting memorandum, all parties' comments on the memorandum, and the Commission's
11 public meeting date. Staff has contacted the parties in the docket regarding this motion. All
12 parties support Staff's proposed schedule changes.

13 **DISCUSSION**

14 The current schedule of events remaining in this docket and Staff's proposed changes are

20 Portland General Electric Company (PGE or Company) filed Final Comments on its
21 Integrated Resource Plan (IRP) in this docket on January 17, 2020. PGE's Final Comments
22 included updated analyses following an extension of the PTC in December 2019, among other
23 items. A special public meeting took place on January 30, 2020, at which PGE, Staff and other
24 interested parties provided comments and answered questions related to the Commission's issues
25 list.

1 Under the current schedule, Staff's public meeting memorandum is due to be filed
2 February 7, 2020. With limited time between the January 30, 2020 special public meeting and
3 this filing date, Staff is unable to address the comments provided, and has had limited time to
4 assess the new analysis provided in PGE's Final Comments. Staff's proposed changes to the
5 procedural schedule will allow Staff adequate time to prepare a public meeting memorandum
6 and for the other parties to prepare comments on Staff's memorandum.


7 **CONCLUSION**

8 For the foregoing reasons, Staff asks that the ALJ grant the above request to modify the
9 procedural schedule on an expedited basis.
