9 Staff of the Public Utility Commission of Oregon (Staff) moves to modify the procedural 10 schedule for this docket. As Staff stated on page two of its Round 2 Comments, filed 11 January 24, 2024, "Because PacifiCorp will not voluntarily make changes to this IRP/CEP, some 12 of the most important issues before us lack a shared analytic foundation from which an 13 acknowledgement determination can be made." Accordingly, Staff does not see a path for 14 recommending acknowledgment of PacifiCorp's IRP/CEP. The commission may also reach this 15 conclusion. As such, time is limited for the utility to adopt a CEP that can be acknowledged and 16 successfully implemented before the first emissions reduction target in 2030 per ORS 469A.410. 17 Staff therefore recommends modification of the procedural schedule to allow the Commission to 18 consider the information presented by Staff and allow for timely consideration of the 19 commission's decision on acknowledgment during preparation of the Company's 2024 IRP 20 Update. If this schedule modification is adopted as proposed, Staff intends to file a brief staff 21 report, attaching its Round 2 comments on February 7, 2024. Responsive comments to that filing 22 may be filed on February 14, 2024, in advance of a public meeting on February 20, 2024, for a 23 commission decision. 24 Staff counsel notified interested parties of these proposed changes on Friday, 25 January 26, 2024. PacifiCorp, the Alliance of Western Energy Consumers (AWEC), Oregon
