11 2010, for the submission of the lists.

12 Staff has discussed this motion with all of the utilities affected by SB 408, and they agree
13 to the change. Staff has also obtained the agreement of the Industrial Customers of Northwest
14 Utilities in connection with dockets UE 177 (PacifiCorp) and UE 178 (Portland General
15 Electric), and the Citizens' Utility Board.

16 Finally, Staff has contacted Northwest Industrial Gas Users in connection with dockets
17 UG 170 (NW Natural) and UG 171 (Avista), and they do not object to staff's motion.
