

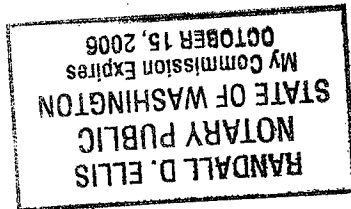


I, DONALD W. SCHOENBECK, being duly sworn on oath, depose and say:

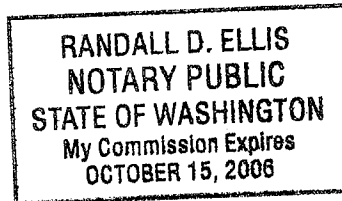


