On July 25, 2006, the Administrative Law Judge issued a Ruling granting a motion filed by Portland General Electric ("PGE") and supported by several parties in this docket. The Ruling modified the schedule to eliminate a testimony filing date with respect to direct access testimony. The motion was made because settlement terms had been agreed to among the parties with respect to direct access issues. The Ruling set a date of August 15, 2006, for filing the settlement of direct access issues.

It has taken longer than anticipated to work out the language of the Stipulation. As a

result, the Stipulation will not be filed today as required by the Ruling. PGE believes that final language for the Stipulation will be agreed to very soon, at least in the next few days. As a result, PGE requests that the deadline for filing the settlement be extended to Monday, August 21, 2006. The Ruling allowed 10 days for challenges to the settlement. PGE does not request a change in that timeframe. PGE further requests that if there is a request for a hearing filed with respect to this settlement, that the hearing be held on September 6, 2006, or as soon thereafter as the Commission's schedule allows.

CONCLUSION AND EXPEDITED CONSIDERATION REQUEST

For the reasons discussed above, PGE requests that the administrative law judge issue an order extending the date for filing of the settlement regarding direct access issues. Since the deadline is currently today, expedited consideration of this motion is requested.
