9	Pursuant to OAR 860-013-0031, staff of the Public Utility Commission ("staff") requests		
10	that the administrative law judge modify the procedural schedule in the above-captioned case to		
11	allow staff and intervenors additional time to file testimony regarding Portland General Electric		
12	Company's ("PGE") cost of equity, cost of debt, cost of preferred stock and overall required rate		
13	of return. This motion is supported by the Citizens' Utility Board ("CUB") and the Industrial		
14	Customers of Northwest Utilities ("ICNU"). To staff's knowledge, these are the only two		
15	intervenors filing testimony on these issues. F	urther, Portland General Electric does not object	
16	to this request.		
17	The extension is needed because PGE re	ecently notified staff, ICNU and CUB that it had	
18	discovered errors in the cost of debt analysis included in PGE's direct testimony. 1 The changes		
19	significantly impact staff's analysis of PGE's cost of debt and may impact the analysis being		
20	done by CUB and ICNU. Because PGE only recently notified staff, CUB and ICNU of the		
21	errors, these parties require additional time to prepare their cost of debt testimony. Furthermore,		
22	CUB, ICNU, PGE and staff have agreed to a three-business day extension for the remainder of		
23	the intervenor/staff cost of capital testimony.

26	PGE intends to correct its testimony via supplemental exhibits filed no later than August 4,
