## [EXPEDITED CONSIDERTAION REQUESTED]

Portland General Electric ("PGE") hereby moves for an extension of time in which parties may file Reply Briefs. Due to the demands of other dockets, and the time necessary to respond to the brief filed in this docket, PGE requests that the deadline for reply briefs be moved to February 6, 2008. The only parties that filed opening briefs were PGE, Staff of the Public Utility Commission, the Department of Energy and the Citizens' Utility Board.
