Pursuant to OAR § 860-013-0031, the Industrial Customers of Northwest Utilities ("ICNU") submits this Expedited Motion to Modify the Schedule in Public Utility Commission of Oregon ("OPUC" or the "Commission") Docket No. UE 197. ICNU respectfully requests that ALJ Arlow rule on this motion by Wednesday, September 10, 2008. the schedule and the response time for data requests. ICNU also contacted, OPUC Staff, the

Citizens' Utility Board ("CUB"), and all other parties on the service list in this proceeding.

Kroger and Staff support this motion. CUB, Community Action Partnership of Oregon, and the

Department of Energy do not oppose this motion. ICNU does not request modification of any

other dates in the schedule.
