1 BEFORE THE PUBLIC UTILITY COMMISSION OF OREGON 2 **UE 200** 3 In the Matter of: 4 PACIFICORP'S MOTION TO VACATE 5 PACIFICORP, dba PACIFIC POWER HEARING 2009 Renewable Adjustment Clause 6 Schedule 202 7 On September 3, 2008, ALJ Patrick Power modified the schedule in this 8 9 proceeding to include an additional day of hearing on September 15, 2008, for the crossexamination of Staff witness Deborah Garcia, because Ms. Garcia was not available for 10 cross-examination on September 8, 2008. PacifiCorp stated in its cross-examination 11 statement on September 2, 2008, that it would be cross-examining Ms. Garcia on the 12 issue of Staff's proposed operations and management ("O&M") adjustment. No other 13 party indicated that it would cross-examine Ms. Garcia. 14 Concurrently with this Motion to Vacate Hearing ("Motion"), PacifiCorp, Staff, the 15 Citizens' Utility Board ("CUB"), and the Industrial Customers of Northwest Utilities ("ICNU") 16 filed a Partial Stipulation reflecting the parties' settlement of the O&M adjustment. This 17 Partial Stipulation resolves the issue that would have been the subject of PacifiCorp's 18 cross-examination of Ms. Garcia. Therefore, the Parties request that ALJ Power vacate 19 the hearing currently scheduled for September 15, 2008. The Parties, however, request 20 that ALJ Power keep the record in this proceeding open until the end of the day on 21 September 15, 2008, because Parties may be submitting additional exhibits into the 22 record on that date. 23 24 25 26 ¹ Staff, CUB, and ICNU stated that they support this Motion.
