Pursuant to OAR 860-013-0031, Portland General Electric Company ("PGE") requests that the schedule in this docket be amended. Specifically, PGE requests that the date currently set for Staff and Intervenor testimony, July 1, 2009, be delayed one week to July 8, 2009. The other parties to this docket, Staff of the Oregon Public Utility Commission, the Industrial Customers of Northwest Utilities, and the Citizens' Utility Board, support this motion.
