MOTION TO SUSPEND PROCEDURAL
SCHEDULE

Staff of the Public Utility Commission of Oregon (“Staff”) asks the hearing officer for an order suspending the procedural schedule in the above-captioned docket.¹ Staff has consulted with the other two parties to this docket, Citizens’ Utility Board of Oregon (“CUB”) and Idaho Power Company (“IPCo”) and neither opposes this motion.


The current schedule calls for response testimony by CUB and Staff on May 24, 2011; Idaho Power reply testimony on June 7, 2011, and a hearing and briefing in June and July, 2011. Neither Staff nor CUB have identified issues presented by Idaho Power’s filings in this docket and all parties to the docket anticipate that this docket will be resolved by Stipulation. For this reason, neither CUB nor Staff intend to file testimony in this case and intend to meet with Idaho Power for a settlement conference the week of June 6, 2011.

Staff anticipates that the parties will reach a settlement prior to June 15, 2011. Counsel for Staff will file a status report in this docket on June 15, 2011, reporting on the parties’ progress.
