Mr. Graves' testimony should be stricken for the reasons identified in the Industrial Customers of Northwest Utilities' (ICNU's) Motion to Strike Surrebuttal Testimony of Frank C. Graves ("ICNU's Motion"). Accordingly, CUB adopts the legal arguments and analysis in ICNU's Motion and requests that the Company's surrebuttal testimony of Frank Graves be stricken.
