11	The testimony at issue is related to PacifiCorp's coal fuel burn expense and recommends		
12	a downward adjustment of \$441,000 to PacifiCorp's net power costs. The testimony is very		
13	similar to testimony filed in PacifiCorp's last rate case, UE 216.		
14	As explanation for Staff's motion to admit this limited testimony out of time, Staff notes		
15	that the testimony was prepared by Brian Bahr, a new employee to Staff. The testimony was		
16	prepared and ready for filing previous to the filing date. However, because Mr. Bahr does not		
17	work on Fridays he was unaware that his prepared testimony was not filed until today. Staff also		
18	notes that allowing the testimony should not cause undue hardship because the adjustment is a		
19	very small percentage of the requested increase in net power costs.		
20	To mitigate Staff's mistake, Staff is willing to extend PacifiCorp's response time to this		
21	Staff testimony by three days because this portion of the testimony is submitted three days tardy.		
22	Staff apologizes for its oversight and the inconvenience caused on the parties and the		
23	Commission.
