3. My Testimony and Exhibits that were previously filed are true and accurate. My testimony would be the same today as that reflected in my pre-filed testimony.

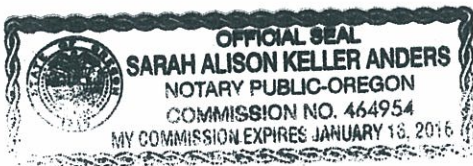
