
Pursuant to OAR 860-001-0420, Noble Americas Energy Solutions LLC (“Noble Solutions”) hereby moves to modify the procedural schedule in this docket. Noble Solutions, along with several other parties, have made a good faith effort to confer to reach agreement regarding this proposed change to the procedural schedule, as described herein. *See* OAR 860-001-0420(3). No party has opposed this proposed schedule modification.

At the time of adoption of the existing schedule, PacifiCorp indicated it may file a motion to request that Administrative Law Judge Kirkpatrick certify the ruling issued on November 15, 2013 to the Commission. *See* OAR 860-001-0110. However, PacifiCorp ultimately decided not to pursue certification. The parties subsequently discussed proposing a modified schedule that is less protracted than the existing schedule. An initial proposed modification was circulated to all parties via e-mail on December 13, 2013. A final set of proposed dates incorporating all requested revisions was circulated via e-mail to all parties on December 18, 2010. Those are the dates set forth in Exhibit A. Several parties have expressly agreed to these dates, including PacifiCorp, Commission Staff, Shell Energy North America (U.S.) L.P., Constellation NewEnergy, Inc., Industrial Customers of Northwest Utilities, and the Northwest and Intermountain Power Producers Coalition.

Therefore, Noble Solutions respectfully requests adoption of the proposed schedule modification. Although several parties have expressly agreed to these proposed dates and no party has voiced any objection, Noble Solutions has not received affirmative agreement from each of the numerous parties to this proceeding regarding this request. Thus Noble Solutions recommends providing seven days for response pursuant to OAR 860-001-0420(5), prior to ruling on this proposed schedule modification.
