All the parties to this proceeding respectfully request or do not oppose that the Oregon Public Utility Commission (the "Commission") Administrative Law Judge ("ALJ") suspend the current schedule and set a prehearing conference to determine a new schedule. All the parties except Portland General Electric Company ("PGE") request that the ALJ suspend the schedule on an expedited basis because PacifiCorp's rebuttal testimony, and Staff and intervenors' cross answering testimony are due on October 18, 2013.

The parties to this proceeding, except PacifiCorp and PGE, have reached a comprehensive settlement of all issues in this proceeding ("Stipulation"). The parties to the Stipulation include the Commission staff, the Industrial Customers of Northwest Utilities, Noble Americas Energy Solutions LLC, Wal-Mart Stores, Inc., Shell Energy North America (US), LP, Constellation NewEnergy, Inc., Fred Meyer Stores, Inc./Kroger, Co., the Northwest and Intermountain Power Producers Coalition, Safeway Inc., and Vitesse LLC ("Stipulating Parties"). The Stipulating Parties filed their Stipulation on October 14, 2013.

The Stipulating Parties have conferred with PacifiCorp and PGE regarding this

Motion. PacifiCorp supports suspending the schedule and holding a prehearing conference to set

a new schedule for testimony and legal briefing. PGE takes no position on any issues in this motion.

The Stipulating Parties are aware that there is a dispute between the Stipulating Parties and PacifiCorp regarding whether the Stipulation is a proper stipulation that satisfies the criteria set forth in OAR 860-001-0350 or is a common joint position, and whether or not the positions in the Stipulation supersede the Stipulating Parties' previously filed testimony. Instead of attempting to characterize the positions of the parties in this joint motion, both the Stipulating Parties and PacifiCorp respectfully urge the ALJ to allow additional written and/or oral argument on the issues of whether the filing made on October 14, 2013 is a compromise in positions contemplated by OAR 860-001-0350 or a joint common position, and whether the document filed on October 14, 2013 supersedes the Stipulating Parties' previously filed individual testimony.
