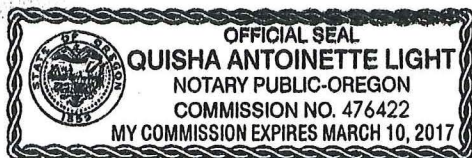
I, ROB MACFARLANE, being first duly sworn on oath, depose and say:


