

I, Ronald Joseph White, Jr., being first duly sworn on oath, do depose and say:

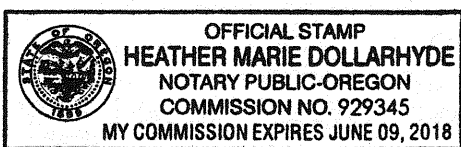
