11	• Staff and Intervenor Rebuttal and Cross Answering Testimony on Coal Decommissioning						
12	Costs and Independent Evaluator (IE) Report – July 17, 2020						
13	The necessity of a separate schedule for the above issues, given the timing of the IE Report, was						
14	contemplated by Staff, Oregon Citizens' Utility Board (CUB), the Alliance of Western Energy						
15	Consumers (AWEC) and PacifiCorp prior to the Commission's appointment of the Independent						
16	Evaluator at its May 7, 2020 special public meeting, which informed these parties' support for						
17	the timing included in the IE contract. Accelerating the date for Staff and Intervenor Rebuttal						
18	and Cross-Answering testimony, as set forth above, strikes a balance between the time remaining						
19	in the schedule to address these issues between PacifiCorp and Staff and Intervenors. The						
20	remainder of the schedule would remain unchanged, with PacifiCorp's response to the IE report						
21	and Staff and Intervenors' positions to be included in its surrebuttal testimony as already						
22	scheduled.						
23	Staff has conferred with all parties to this proceeding, and no party objects to Staff's						
24	Motion. Because the due date for Staff and Intervenor testimony on these issues is proposed to
