9	Staff of the Public Utility Commission of Oregon ("Staff") asks the Administrative Law

10 Judge (ALJ) to modify the procedural schedule in this docket to extend the due date for Staff and Portland General Electric Co. (PGE) to file a Process to Conduct Revenue Requirement/Rate 11 Spread Scenarios asked for the by the Administrative Law Judge at the August 2, 2021 12 prehearing conference. Because the filing is due today, Staff asks for expedited consideration. 13 Staff has contacted all UE 394 parties regarding this request: Walmart Inc., Calpine Solutions, 14 Fred Meyer Stores, Inc., and Quality Food Centers, Divisions of the Kroger Co. (Kroger), the 15 Oregon Citizens' Utility Board, the Alliance for Western Energy Consumers, Northwest and 16 17 Intermountain Independent Power Producers, and PGE. All parties have indicated they do not object to either the request for expedited consideration or the request for extension. 18 On August 3, 2021, the ALJ issued a Prehearing Conference Memorandum specifying 19 20 that the Proposal for Process to Conduct Revenue Requirement/Rate Spread Process Scenarios is due on August 30, by 3 p.m. Staff and the Portland General Electric Company (PGE) have 21 22 discussed the process on multiple occasions but have yet to agree on a Proposal. Accordingly, Staff asks for additional time in which to meet with PGE and come to agreement. 23 Staff e-mailed UE 394 parties the morning of August 30, 2021, notifying parties that 24 Staff intended to ask for a two-week extension in which to file the proposal asked for by ALJ 25 26
