All other dates set forth in the Administrative Law Judge’s November 24, 2021 Memorandum would remain unchanged. The purpose of this extension is to provide the parties additional time to evaluate the impact of the recently completed Third Partial Settlement on outstanding cost-of-service and rate design issues.
