(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests the Public Utility Commission of Oregon (Commission) issue an order waiving: (1) the February 16, 2023 hearing established in the Administrative Law Judge's Ruling filed to this docket on December 7, 2022; and (2) the associated February 13, 2023 requirements to file a list of active participants in the hearing and cross-examination statements, as provided within the Commission's Memorandum filed to this docket on January 31, 2023. The Oregon Citizens' Utility Board (CUB) has indicated that it has additional exhibits it intends to submit for admission into the administrative record on February 13, 2023.

PacifiCorp has conferred with Commission Staff, CUB, and the Alliance of Western Energy Consumers (collectively "the Parties") and each party has agreed to waive the hearing and these filing requirements and believes that the narrow scope of contested issues raised in this docket, pertaining to the Stipulation filed on December 29, 2022, can be appropriately addressed in the scheduled rounds of briefing. PacifiCorp nor the Parties have

any cross-examination questions for any witness who has submitted testimony to this docket and believes that the Commission should grant the relief requested in this Motion.
