PACIFICORP'S MOTION TO MODIFY PROCEDURAL SCHEDULE

(Expedited Consideration Requested)

In accordance with OAR 860-001-0420, PacifiCorp d/b/a Pacific Power (PacifiCorp) respectfully requests that the Public Utility Commission of Oregon (Commission) issue an order suspending the procedural schedule in this docket. PacifiCorp, Commission Staff, and the Alliance of Western Energy Consumers (AWEC), have developed a full settlement of all the issues in this docket, and suspension of the procedural schedule will allow for the filing of a settlement and supporting testimony. The Oregon Citizens' Utility Board (CUB) has indicated that they will not be joining this settlement. Because Staff and Intervenor testimony is due December 8, 2022, PacifiCorp requests expedited treatment of this motion in accordance with OAR 860-001-0420(6). PacifiCorp has contacted Commission Staff, CUB, and AWEC and no party opposes this motion. The settling parties intend to file the settlement and supporting testimony by December 30, 2022. Since this is a non-unanimous settlement, PacifiCorp has conferred with the parties and developed the procedural schedule identified in the table below. This schedule maintains the hearing date and briefing schedule previously adopted by the Commission for this proceeding.
