MOTION TO ADMIT SECOND STIPULATION AND JOINT TESTIMONY

On October 24, 2022, Portland General Electric Company (PGE), the Staff of the Public Utility Commission (Staff), the Oregon Citizen's Utility Board (CUB), and the Alliance of Western Energy Consumers (AWEC) (jointly, the "Stipulating Parties") submitted for Commission approval a partial stipulation concerning the amortization of 2021 deferred amounts for the Boardman coal plant (the "First Stipulation"). After continued discussions, the Stipulating Parties reached a settlement agreement on the amortization of 2020 amounts as well as an agreement that no amounts are to be refunded for 2022 (the "Second Stipulation").

Pursuant to OAR 860-001-0350(7), PGE, on behalf of the Stipulating Parties, moves to admit into the record in this proceeding the Second Stipulation, dated May 30, 2023. PGE also moves that the following Joint Testimony in support of the Second Stipulation and witness affidavits be admitted into the record as evidence in this proceeding:
