**MOTION TO ADMIT FIRST
STIPULATION AND JOINT TESTIMONY**

Portland General Electric Company (PGE), the Staff of the Public Utility Commission (Staff), the Oregon Citizens' Utility Board (CUB), and the Alliance of Western Energy Consumers (AWEC) (jointly, the "Stipulating Parties") reached an agreement that resolved some of the pending issues in UE 410. The First Stipulation resolves issues in UE 410 concerning the treatment of 2021 Boardman related deferred amounts, however, treatment for 2020 is still a contested issue.
