**MOTION TO ADMIT FIRST AND THIRD  
PARTIAL STIPULATIONS RELATING TO  
ANNUAL POWER COST UPDATES**

Portland General Electric Company (PGE), Staff of the Public Utility Commission of Oregon, the Oregon Citizens' Utility Board, the Alliance of Western Energy Consumers, and Walmart, Inc., (collectively, the “Stipulating Parties”) after conducting settlement conferences on June 14, 2023 and July 11, 2023, have reached partial settlements on the topic of net variable power costs memorialized in the First and Third Partial Stipulations. Calpine Solutions, Community Action Partnership of Oregon, and Natural Resources Defense Council did not take a position on the issues resolved by this Stipulation and are not a party to the stipulations. Fred Meyer Stores and Quality Food Centers, Division of The Kroger Co. does not oppose the stipulations.

Pursuant to OAR 860-001-0350(7), PGE, on behalf of the Stipulating Parties, moves to admit into the record in this proceeding the First Partial Stipulation, dated June 14, 2023, and the Third Partial Stipulation, dated July 11, 2023. OAR 860-001-350(7)(a) includes a requirement to file an explanatory brief or written testimony in support of stipulation. PGE files separately Joint Testimony in support of the First and Third Partial Stipulations (Stipulating Parties Exhibit 100).

PGE hereby requests the Commission issue an order approving both the First Stipulation and the Third Stipulation without modification. Stipulating Parties support this motion.
