My name is José I. Galindez Mesa, with my wife Elena a resident of Beaverton since 1994. I retired from Columbia Helicopters in 2021, am an ex-Intel employee of many years and also was active civically as a member of the Beaverton Budget committee from 2006 until 2021, serving at the pleasure of Mayors Drake, Doyle and Beaty, and was the Committee's Chair five years of the fifteen years I served the City, and you can find me on LinkedIn if you want further information on me.

During those 15 years I believe I established a reputation for being both a strong advocate of a strong, able, well-funded City and Police Force while being watchful of needless or unwarranted spending. Indeed, in 2008 I led a negotiation within the Committee and Council members to undo a proposed city millage rate hike by identifying areas of the general fund which could be trimmed without ill effects to the City's principal objectives and transferring said funds to the areas where funding was needed, avoiding what would have been a very ill-timed and socially impactful rate hike which would have taken effect during the onslaught of the housing crash of 2008 to 2010.

I find myself in the same situation today with the roughly 16% rate increase PG&E is requesting for 2024 and beyond -an increase completely unjustified given the cost of Natural Gas is within a few pennies of its 30-year low set in March 2020 during the onset of the stock and commodities crash of the Pandemic -easily verifiable data by looking at the following chart: <a href="https://www.macrotrends.net/2478/natural-gas-prices-historical-chart">https://www.macrotrends.net/2478/natural-gas-prices-historical-chart</a> Beyond the data showing NG at generational lows today, the forecasts for the 2H 2023 and 1h2024 are not much better (higher) as the NG Futures also suggest a year or more at these almost-generational lows -yet against this situation, we are all paying the 7% increase PG&E's successfully lobbied for last January 1st. Thanks to that 7% increase, PG&E has been enjoying record-high billing rates while paying almost record-low prices for gas -a situation totally incompatible with 'a need for another increase'.

Oregon is not a 'low-cost' state -but power and water costs are one of the areas where we do have a competitive advantage to many other states. Given its effect on our already-high cost or living, the fact that power costs have a similar impact to households as does a very regressive tax, and its effect on our state's competitiveness, this increase of 16% when PG&E's feedstock costs (water and gas) are in abundance (water) and cheap (gas) should be a non-starter for any Oregonian to consider. I urge you to decline this increase and will immediately kick off additional efforts within my friends, contacts, family and members of the press to further and more actively support this request to deny PG&E their request for a ridiculous price increase.

Greetings!

Regarding the PGE Rate Increase Request, I would like to submit the following response. I will be brief, but I do request that you review the response, and provide an answer as to how you respond to the PGE Request.

- 1) The amount of rate increase (14.4%, as I understand it) is excessive, compared to the incomes of the population that would have to pay this amount. For example, for several years, Social Security recipients got very small raises, or no raise at all. For 2023, there was a COLA of about 8.7%. This is helpful, but will likely not happen again. In the future years, when Social Security may eventually be cut, PGE would still be expecting ratepayers to pay the higher amounts, taking a proportionately higher amount of the Social Security recipient's income from them. In general, many companies are giving raises of about 3%, maybe 5%, to their workers. Does PGE have the right to demand a higher percentage of the worker's income?
- 2) It was indicated that PGE wants the rate increase to build new projects, or make improvements to existing installations. But consider this: PGE will be doing these projects so that they can make more money selling electricity. Is it right for PGE to make the ratepayers pay for these improvements, so that PGE can make more money? Any other entity that wants to build a building, or some other type of facility, to make a profit, will borrow the needed money, and pay it back from their revenues. PGE is expecting lower-paid people to give them the money, interest-free, so that they will not have to pay the money back, and thus have even greater profits from these ventures.
- 3) Consider the chaos our economy would be in if all service providers, landlords, lenders, or sellers raised their rates in the proportion that PGE is proposing. Is it fair that PGE would be allowed to raise their rates in this proportion?

The above items point to one thing: Greed on the part of PGE. It is obvious that they neither understand their customers, nor do they care about them. They only want to take money from us. If the role of the Public Utility Commission is to provide any protection for the citizens of Oregon, I would urge you to NOT allow this increase.

We have nowhere near that now. In the following paragraphs, here are some considerations:

- \* I volunteer at a local St Vincent De Paul food pantry. We also help our clients with rent and utilities assistance. Our average client is under pressure from all 3 needs-food, rent and utilities. I can tell you that our available food assistance appointments have been booked, mostly solid for the foreseeable future. Our rent and utility allocations are per month and are typically exhausted within the first 2 weeks as it is. The most needy in our community are already struggling mightily. Why does PGE seek this huge of an increase and how do they justify it after an already huge increase this year?
- \* There are already indications that job layoffs in several employment sectors are increasing and wage gains are slowing as corporations seek to cut their costs. With the fed's 25 basis points increase in the interest rate only seems to add insult to injury. I don't personally know of any of my working friends who have received a 14% pay raise this year.

Please seriously consider substantially reducing the rate increase request. Or at least help me to understand why they are going after this magnitude of an increase. I know PGE isn't the only utility seeking this type of increase, so please deny them this level of increase, particularly for the good of our neighbors most in need.

# RE: UE 416 Request for a General Rate Revision and 2024 Annual Power Cost Update

Dear Chair Decker, Commissioners Tawney and Thompson,

I am writing on behalf of the Community Action Partnership (CAPO), which represents a network of 17 Oregon community action agencies and a special purpose organization, the Oregon Human Development Corporation. Our organizations plan, implement, and deliver anti-poverty programs across all of Oregon's 36 counties, including homeless shelters, food banks, and Head Start. Our network is also responsible for implementing state- and federally-funded weatherization programs (e.g. ECHO, WAP) as well as energy assistance programs (e.g. LIHEAP, OEAP). Our advocacy is based on this experience. We serve tens of thousands of low-income households every year. Please consider our suggestions not only as ways to improve the situation of those households, but also as what we believe is in the best interest of society at large.

We urge you to deny PGE's request for a General Rate Revision if no significant revisions to the request are made. As you know, one of the regulatory principles applied to utility general rate cases is to protect the public interest, ensuring rates are fair, just, and reasonable.¹ We believe that the proposed rates do not meet this standard and will unfairly burden low-income customers. Fair, just, and reasonable are not apolitical terms that can be calculated by technical procedures alone, although rate cases may suggest so at times.² Before accepting any settlement by intervening parties, we urge the Commissioners to consider what is in Oregon's public interest, as articulated by the State Legislature, and make tariff modifications to that effect.³ For instance, the legislative intent of HB 2475, passed in 2021, is clearly to make energy burden and affordability of service to low-income customers a more important consideration in ratemaking. Therefore, we urge you to revise the following elements before accepting new rates. Because of time- and resource limitations, this is not a complete list of issues relevant to low-income customers.

#### **Residential Rate Increases and Low-Income Rates**

Whether the interests of low-income customers need to be taken into account during ratemaking is not in question. HB 2475 clearly gives the OPUC the authority to consider low-income customers as a class; the existence of PGE's bill discount program, financed by all ratepayers, sets clear precedence that considerations of energy burden are in the public interest, and that this is congruent with principles of fairness, justness, and reasonableness. Unfortunately, PGE's current bill discount program is insufficient to substantially relieve energy burden at the lowest ends of the income distribution. This is exacerbated by the proposed rate increase.


The chart on the right shows the kind of information OPUC should consider when responding to the PGE rate request. The chart illustrates PGE's current bill discount program and the discount percentage

a fictional 2.6 person average household would require to remain under 6% of income, generally considered as energy burden threshold (bill of \$1,471 annually). We can see that at about 25% of SMI (\$18,000) the discount program becomes ineffective at its goal of relieving energy burden.

The next chart shows the same calculation with PGE's proposed rate increase. Now average energy bills become unaffordable for the average 2.6-person household at around 30% of SMI.

This is a very crude analysis that underestimates the amount of assistance needed. Required discounts will be larger for smaller households, because their income is lower, but their energy usage/bills are not proportionally smaller. Furthermore, this is not based on actual usage data of these customers. According to PGE testimony, many low-income customers have above average usage, for instance due to insufficient insulation. Better program design would take these factors into account. A low-income needs assessment to determine appropriate program design should be part of the rate case.

We can see that current bill discount programs do not fulfill their promised goals and the proposed rate



increase worsens this problem. Furthermore, to be considered fair, enrollment rates must be close to 100% of the eligible population. Currently, only 50% are enrolled. This means, there are many people of very limited means that are subsidizing the bill discount program despite struggling to make payments themselves. This must be considered in the rate case as well. We propose two options:

- Analysis in the rate case should include a low-income needs assessment to define current
  parameters better. Adjust bill discount rates to keep all low-income customers under the 6% of
  income energy burden threshold. Consider creative mechanisms to increase enrollment (e.g.,
  automatic enrollment by census tract). Ensure customers stay enrolled despite income
  verification and 2-year re-enrollment requirements. Create binding enrollment targets for PGE.
  Provide better coordination with other existing assistance programs. Ensure assistance has
  been individually offered before disconnection is used as a collection tool.
- Require PGE to treat low-income customers as separate customer class. Conduct a low-income needs assessment for the rate case, in the same way other cost scenarios are modeled. Ensure that this class has affordable energy bills.

Low-income rates or discounts need to be considered in the context of other special rates that PGE is proposing to customers. Most are aimed at customers with resources and flexibility. For instance, Schedule 5 (Residential Direct Load Control Pilot) will be only available to customers with appliances controlled by smart thermostats. Similarly, consumers most likely to be able to take advantage of Time-of-Day rates or Peak Time Rebates (Schedule 7) will be those with job flexibility and access to battery storage. EV incentives are only available to those that can afford to purchase a brand-new electric car. This is not to say that any of these new schedules are bad ideas, they might even be great ideas. However, fairness would mandate that low-income interest must receive a similarly strong consideration. It is disheartening to find little mention of low-income impacts in discussions about cost causation, true-ups, return on equity, and new schedules in the current rate case. Statements in testimony claiming that existing discount programs somehow mitigate the impacts of rate increases are illogical.<sup>4</sup> Arithmetically, the percentage rate increase remains the same independently of enrollment in a discount program.

In sum, we consider keeping energy affordable as one of the primary public interest considerations OPUC must make in this rate case, in addition to keeping PGE in business and reducing GHG emissions. Electricity is essential to survive and thrive; everyone, independent of income, must be able to access it. Proposed rates unfairly shift the cost of providing service onto low-income customers. We have listed some potential remedies. They would not only have societal benefits but also direct business benefits in the form of less uncollectible debt and a larger customer base to spread fixed costs over.

# **Return on Equity**

We believe it is a bad look for PGE to propose an increased return on equity at the same time as asking for substantially higher electricity rates. PGE shareholders and executives should be required to lower their current enumeration. This would show solidarity among all company stakeholders and make rate increases more palatable for ratepayers. Trust and community support in turn are a good basis for being able to raise capital cheaply.

While as non-experts we cannot comment on the exact risk calculations that went into the proposed return on equity, we can contribute to common sense considerations of underlying concepts. How risky is it really to invest in PGE? PGE is a government-regulated monopoly; customers are completely dependent on the delivery of electricity and must, in the end, pay any rate required to continue delivery of electricity. As such, there is very little risk for shareholders. Furthermore, in case of bankruptcy, a government bailout or brokered deal is basically guaranteed. In many such cases, there are few losses for investors. Investing in PGE is a little like holding funds in a bank account above FDIC-insured limits. Is it theoretically possible to lose that money? Yes. But as recent experiences show, government agencies are extremely unlikely to let that happen.

Lastly, to the outsider, determining rates of return by comparison to similar utilities is problematically self-referential. If all peer utilities were to use this method, the result would be ever increasing returns on equity, since any one increase, will increase the average, justifying more increases among the others.

### **Rate Cases as Participatory Processes**

As an organization, we are committed to principles of environmental justice. To us that means: (1) considering explicitly the distribution of costs and benefits of producing and consuming energy. Making distribution decisions in line with the public interest and with special consideration for those least able to bear the costs. (2) Robust participation in decision-making by those most affected. (3) Recognizing unequal historical impacts of power generation on marginalized populations and providing remedies.

Values of environmental justice have made recent appearances in federal and state legislation, as well as in statements by this commission. Unfortunately, they are not reflected in how this and other rate cases are currently adjudicated. We ask that rate cases are restructured to allow for more substantive dialogue with the public on the political and legal issues raised by the rate case. At the heart of that must lie the recognition that setting rates is not an apolitical, technical process that can be conducted

like a court proceeding, but an exercise in arbitrating between different values and political priorities. To make this possible, we would like to see:

- Utility filings that are understandable to educated lay persons.
- Summaries by the OPUC, directed at the public, that explain the competing values and assumptions underlying current rate cases.
- Hearings where members of the public can directly interact with utility companies and intervenors.
- An end to resolving rate case issues in private settlement conversations.

In conclusion, I respectfully request that the commission and other parties involved in the rate case process consider the points mentioned above. Ensuring reliability, affordability, and safety while appropriately distributing the costs associated with new regulations and EV charging stations is crucial for a fair and balanced outcome.

### Commissioners,

I would first like to thank the Commission for the opportunity to comment on a proposed rate increase that, if approved, will have a major impact on small businesses served by Portland General Electric (PGE).

I am writing on behalf of the Oregon chapter of the Small Business Utility Advocates or SBUA. I reviewed the recent filing made by Portland General Electric (PGE) where it asks for increased revenues of \$338 million, or a 14.47% increase over current levels.


## I will address the following:

- The size of the increased cost burden of the rate proposal on small nonresidential customers.
- The extraordinary increase in the cost of distribution charges to small nonresidential customers under both schedule 32 customers and schedule 532, small nonresidential and small nonresidential – Direct Access Service respectively, in excess of 5,000 kWh.
- Small business in Oregon, including those served by PGE, are still recovering from the economic impact of COVID-19.
- Need for a small business workshop to discuss and understand the needs of small businesses being serviced by Oregon's public utilities.

## The size of the increased cost burden of the rate proposal on small nonresidential customers.

Under the Company's proposal, small businesses will pay \$34.6 million more for service, a 15.9% increase for service. This sizable increase on to small business is the highest increase over test-year amounts than any other class of service.

For the small nonresidential ratepayers (rate schedule 32) the proposal increases the average small business energy bill by 12.6%.<sup>2</sup> What is even more concerning is the proposed increase for small business customers using above 5,000 kWh. For these customers the change in proposed rate climbs to an average of 18.1% for usage from 6,000 to 15,000 kWh and continues to climb as usage increases (see chart below).



 The extraordinary increase in the cost of distribution charges to small nonresidential customers under both schedule 32 customers and schedule 532

The climbing costs of energy above 5,000 kWh is due to a proposed 140.5% increase in the company's distribution charge above 5,000 kWh for small commercial consumers.

The current change of 1.416 cents per kWh skyrockets to 3.406 cents per kWh, under the company's proposal, more than doubling! Effectively a two-cent increase.<sup>3</sup> Though

some of this rate change appears to be associated with higher costs, the company admits that some of the 3.406 cent rate increase is simply to "provide a transition to" the large nonresidential rates schedule (Schedule 83) for customers whose loads exceed 30 kW<sup>4</sup> at least twice during the preceding 13 months.<sup>5</sup>

It is important that the Commission and Commission Staff be aware of this arbitrary adjustment to the small nonresidential rate schedule. Not only is there no testimony discussing why PGE believes there is a need for a rate that mitigates the impact of moving from one class to another, there is no testimony providing discussion on how often a migration to the large-user class happens and indeed if it is even a problem. In his historic discussion of the criteria of a sound rate structure, James Bonbright discusses the need of fairness in rates, there is no discussion of rates that mitigate any class migration.<sup>6</sup>

The increased rate as proposed which is designed to ease transition to a different customer class, simply results in small commercial customers providing either an intraclass or cross-class subsidy to other customers with no other benefits to the small commercial customers that would be burdened with the 140.5% increase in its distribution charges.

A 140.5% increase is unsupportable and must be rejected if not for any other reason than simply rate shock. For every kWh used above the 5,000-kWh level, many small business owners will have their distribution rates more than double, paying 3.4 cents per kWh for a service that currently costs 1.4 cents per kWh!

A Company witness says it best. "It is important to maintain relative consistency with prior cost studies and temper the amount of change introduced...." We agree, and we ask the Commission to apply this very principle to this case. Finally, the "ease of migration" reasoning is a solution looking for a problem; a problem that, to our knowledge, has not been raised in prior cases.

• Small business in Oregon, including those served by PGE, are still recovering from the economic impact of COVID-19.

Although most, if not all, of the health related COVID mandates are no longer required, small business is now addressing COVID's consequences. Not the least and central to small business is rising costs due to high inflation. Add to that the difficulty many small businesses are having in finding employees. In short, this sector remains fragile.

Affordability of utility rates for small business is integral to their survivability. Rising rates can be associated with rising costs. For example, the recent settlement of parties, including SBUA, approved by the Commission spread a share of the deferred costs of COVID to the small business class.<sup>8</sup> As we have noted in previous dockets, this customer class did not directly benefit from most of the Commission approved COVID-19 programs and had little or no indirect benefit.

With this filing, the small nonresidential class may end up absorbing a 15.9% increase in its total electric bills; the largest change of any of the other rate classes. We would ask the Commission to recognize the importance of small business to the communities where they are located and to adjust the proposed rates to help them fully recover from the lingering economic impacts of the recent pandemic.

 Need for a Small Business workshop to discuss and understand the unique needs of small business to allow Oregon's public utilities to better serve them.

Finally, my involvement with recent rate filings has convinced me of the need to convene a Commission supported small-business workshop. A workshop would provide a forum allowing in-depth discussions with Commission Staff by local small business owners. The workshop would allow parties to better understand what challenges the different parties have, including Staff, and what distinguishes small business from other ratepayer classes, especially from the larger industrial and

commercial ratepayers.<sup>10</sup> Commission Staff mentioned being in support of such a workshop at the Commission's March 21, 2023, public meeting<sup>11</sup>.

The workshop agenda could include discussion of those rates and rate structures currently provided only to residential ratepayers, which may be appropriate for small businesses. Or the creation of new rate mechanisms to aid small businesses, e.g., an arrearage forgiveness program for those small commercial customers with a high Environmental Justice Indicator.

Also, unique needs of the small commercial could be discussed by business owners which could be innovative and help develop community growth. Finally, there may be benefit in a discussion on how uniform the methods of cost allocation to small business sector and whether it is something that requires Commission review.

In summary, the small business community served by PGE is concerned about the size of the overall increase and more specifically, how those costs related to the small nonresidential customers are recovered in rates.

Again, I would like to thank the Commission for this opportunity to provide comments.

The Commission Staff should review carefully why the rate is higher and also whether the increased distribution rate is reasonable and based on cost.
