**MOTION TO SUSPEND  
PROCEDURAL SCHEDULE**

***Expedited Consideration Requested***

In accordance with OAR 860-001-0420, Idaho Power Company (Idaho Power or Company) respectfully submits this Motion to Suspend the Procedural Schedule in Docket UE 426. All parties to this case (Idaho Power, Staff, the Oregon Citizens' Utility Board (CUB), Community Energy Project (CEP), and Simplot) have reached a settlement in principle that resolves most issues, with one issue remaining. The parties request suspension of the current procedural schedule to allow time to finalize and execute a settlement stipulation and supporting testimony.

Idaho Power's Reply Testimony is currently due on Tuesday, April 30, 2024. Therefore, in accordance with OAR 860-001-0420(6), Idaho Power requests expedited consideration of this Motion. Idaho Power has conferred with Staff, CUB, CEP, and Simplot. All parties support this Motion and the request for expedited consideration.

The parties anticipate discussing the remaining issue at the upcoming settlement conference on May 6, 2024. In the event that the parties do not reach a settlement, the parties will request the Commission to convene a prehearing conference.
