EXTENSION OF TIME**
Expedited Consideration Requested

PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company), consistent with OAR 860-001-420, respectfully moves the Public Utility Commission of Oregon (Commission) to grant an extension of time to provide the rate adjustment and deferral request information requested to be provided by March 18, 2024, in the Administrative Law Judge Ruling issued on March 6, 2024 (ALJ Ruling). Specifically, PacifiCorp requests a one-week extension or until March 25, 2024, to file the requested information. Good cause exists to grant PacifiCorp’s motion. The Company requests expedited consideration of its motion.¹


On February 26, 2024, the Commission initiated the above referenced proceeding, Subsequently, on March 6, 2024, the ALJ Ruling was issued, which requested PacifiCorp and other utilities to submit the rate adjustment and deferral request information contained in the excel spreadsheet template that accompanied the ALJ Ruling by March 18, 2024. Since the issuance of the ALJ Ruling, the Company has been diligently working on populating the template. Given the scope and complexity of the request, it is taking the Company longer than expected to compile the information. The Company would benefit with an extra week

to file the completed template in order to complete a comprehensive review of the information before its submittal.

For the reasons described in this motion, PacifiCorp respectfully requests the Commission grant a one-week extension or until March 25, 2024, for PacifiCorp to file the rate adjustment and deferral request information requested in the ALJ Ruling.
