Pursuant to OAR 860-013-0031, the Citizens' Utility Board of Oregon ("CUB"), and the Northwest Industrial Gas Users ("NWIGU")(the filing parties) respectfully request that the hearing currently set for September 23, 2009 be vacated and a new schedule be adopted setting time for Simultaneous Opening Briefs due on or before November 6, 2009; Simultaneous Reply Briefs due on or before December 18, 2009; and, a prehearing conference sometime thereafter to determine what if any additional process is necessary - including but not limited to the possibility of additional testimony, briefing and hearings.

The filing parties make this request based on their understanding that the Commission will be requesting comprehensive briefing from the parties in the UG 171 docket on various threshold Constitutional issues which will impact not only UG 171, but also AR 537. It is the filing parties' position that there can be no further process in this docket until the Constitutional issues are resolved and a legal standard is established. Depending on the Commission's determinations, additional testimony, briefing and process may be required in UG 171. Once the threshold legal issues are resolved, the filing parties request that a prehearing conference be scheduled to determine whether any additional process – testimony, briefing and hearing – is needed.

The filing parties also makes this request as a direct result of the filings and schedule set in AR 537. The rule at issue in AR 537 is interrelated with this docket.
