The active parties in this proceeding—Commission Staff, Cascade, the Citizens' Utility Board ("CUB"), and the Northwest Industrial Gas Users ("NWIGU")—have reached an agreement in principle resolving all issues in this docket. The parties expect to file a stipulation memorializing their agreement, along with joint testimony, on or before October 15, 2015. Currently the schedule in this proceeding provides for Staff and Intervenor Rebuttal Testimony to be filed on September 24, 2015, Cascade Surrebuttal Testimony to be filed on October 8, 2015, Simultaneous Pre-Hearing Briefs to be filed on October 19, 2015, a tentative hearing date of October 27, 2015, Cascade's Opening Brief to be filed on

By October 15, 2015, the parties will file documents supporting the settlement or a status update.
