Utility Program Economic Research and Financial Analysis Division.

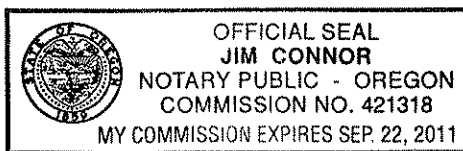
2. In the course of my employment, I sponsored Staff Reply Testimony, a witness
