MOTION FOR CHANGE OF SCHEDULE

7 PacifiCorp requests a change in the schedule set forth in the Ruling and Prehearing
8 Conference Report Memorandum, issued in this case on August 18, 2006. Under this
9 schedule, Reply Comments from all parties are due on October 2, 2006. PacifiCorp
10 proposes a change in this schedule, so that PacifiCorp's Reply Comments, along with a
11 revised draft of the 2012 RFP, will be due on October 4, 2006. Staff and Intervenor Reply
12 Comments to the Opening Comments and to PacifiCorp's October 4, 2006 filing will be due
13 on October 13, 2006.

14 The Commission Public Meeting on this matter would remain as scheduled on
15 October 26, 2006, and all parties could submit additional comments to the Commission up
16 to October 24, 2006. PacifiCorp understands that the Commission intends to take this case
17 under advisement for approximately one week after the public meeting. PacifiCorp therefore
18 suggests a target decision date of November 2, 2006.


19 The revisions to the schedule permit PacifiCorp to respond to the parties' Opening
20 Comments with specific changes to the 2012 RFP, and permit the parties an opportunity to
21 review these changes before submitting Reply Comments. In addition, the revised schedule
22 tracks the newly revised schedule for RFP approval in Utah, allowing the Company to
23 process the cases in an efficient manner in both states.

24 PacifiCorp has contacted Staff, NIPPC, CUB and RNP, all of whom support this
25 motion. PacifiCorp has also contacted ICNU, which supports this motion, with the proviso
26 that they may need to request additional time to respond depending on the nature and

1 scope of the RFP revisions. PacifiCorp left a message with counsel for ODOE, but does not
2 yet know its position on the motion.
