MOTION FOR ISSUANCE OF STANDARD PROTECTIVE ORDER

Pursuant to OAR 860-012-0035(1)(k), Umpqua Indian Development Corporation Telecommunications Division d/b/a Rio Communications ("Rio Communications") hereby respectfully requests entry of a protective order in this proceeding to limit disclosure of confidential information. Rio Communications requests that the Public Utility Commission of Oregon (the "Commission") issue the standard protective order adopted by the Commission.

Rio Communications plans to submit sensitive and proprietary information in support of its Application for Designation as an Eligible Telecommunications Carrier Pursuant to the Telecommunications Act of 1996, such as Rio Communications' projections and strategic plans. Rio Communications will be exposed to competitive injury if it is forced to make unrestricted disclosure of its confidential business information.

OAR 860-011-0000(3) provides that the Oregon Rules of Civil Procedure ("ORCP") govern these proceedings. ORCP 36C(7) provides for the issuance of a protective order providing that "a trade secret or other confidential research, development, or commercial information not be disclosed or be disclosed only in a designated way." Rio Communications requests the entry of the standard protective order to protect such information by limiting
