13	restrictions on discovery of trade secrets and other confidential business information. See			
	OAR 860-11-0000(3) (adopting Oregon Rules of Civil Procedure ("ORCP")); ORCP 36(C)(7)			
15	(providing protection against unrestricted discovery of "trade secrets or other confidential			
16	research, development, or commercial information"). See also In re Investigation into the			
17	Cost of Providing Telecommunication Service (UM 351), Order No. 91-500 (1991)			
18	(recognizing that protective orders are a reasonable means to protect "the rights of a party			
19	to trade secrets and other confidential commercial information" and "to facilitate the			
20	communication of information between litigants").			
21	2. Idaho Power Company anticipa	tes that discovery in this proceeding may		
22	include proprietary business and financial information, and the parties will be exposed to			
23	competitive injury if they are forced to make unrestricted disclosure of confidential business
