PACIFIC POWER MOTION TO MODIFY SCHEDULE

Expedited Consideration Requested

Pursuant to OAR 860-13-031, PacifiCorp, d.b.a. Pacific Power ("Company") moves for a modified schedule in this docket. Additionally, the Company respectfully requests expedited consideration of this Motion because July 18, 2008 is the deadline for filing the next scheduled round of comments in this proceeding. In support of this Motion, PacifiCorp states as follows:

The current schedule in this docket includes July 18, 2008 as the date for
filing of comments on the Company's 2008R-1 Renewable Request for Proposals ("2008R-1
RFP"). The current schedule also includes a placeholder for a public meeting to consider the
2008R-1 RFP.

2. After review of the Public Utility Commission of Oregon Staff's ("Staff") and Intervenors' (collectively "Parties") Opening Comments and the Oregon Independent Evaluator's ("IE") report, the Company believes it would be beneficial to narrow the issues for the Parties to address in their comments on the Final Draft 2008R-1 RFP. Specifically, the Company would prefer the opportunity to work with the IE to prepare more thorough responses and propose language in a revised final draft RFP to address some of these issues.
