4 foregoing is true and correct based on my information and belief.

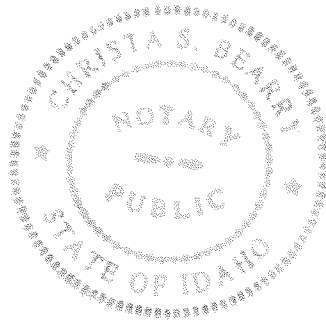
