Pursuant to OAR 860-001-0420, the Northwest and Intermountain Power Producers Coalition ("NIPPC") and Renewable Energy Coalition (the "Coalition") petitions the Oregon Public Utility Commission (the "Commission") Administrative Law Judge, Michael Grant, suspend the procedural schedule and hold this proceeding in abeyance. The parties have been participating in settlement discussions and may be close to an agreement in principle. Although settlement may not occur, NIPPC and REC believe suspension of the procedural schedule is in the interests of all parties so that they may focus on obtaining resolution through settlement.

If settlement is not reached, then a new schedule will need to be adopted, and the NIPPC, REC and the other parties will propose a new schedule or request that the ALJ hold a prehearing scheduling conference to set a new schedule.

NIPPC and REC have conferred with the parties in this docket. At the time of this filing, Community Renewable Energy Association ("CREA"), Renewable Northwest

PacifiCorp, Commission Staff and OneEnergy take no position on the motion. By the time of filing, Heelstone Development and Obsidian Renewables did not respond regarding their position.
