**MOTION TO MODIFY
PROCECURAL SCHEDULE**

***EXPEDITED CONSIDERATION
REQUESTED***

Portland General Electric Company (“PGE”) respectfully requests that the Administrative Law Judge issue an order modifying the procedural schedule in this docket.

The procedural schedule adopted in the Prehearing Conference Memorandum in this docket called for three workshops. Workshop 1, scheduled for December 14, 2017, was cancelled by Staff. That workshop was to have been a stakeholder only workshop. Workshop 2, scheduled for January 12, 2018, is scheduled as a stakeholder and Commissioner workshop. PGE requests that the schedule be amended to designate Workshop 2 as a stakeholder only workshop. PGE believes it will be more efficient if the stakeholders have a workshop among themselves to address questions about the application and other issues, prior to a Commissioner workshop. The current procedural schedule calls for a Commissioner workshop, designated Workshop 3, on February 20, 2018. PGE proposes that Workshop 3 remain as scheduled. If the Commission desires an additional Commissioner workshop, there is time in the schedule either before or after Workshop 3.

PGE does not request any other changes to the procedural schedule.

PGE provided a draft of this motion to the parties to this docket yesterday afternoon. Community Renewable Energy Association, Oregon Citizens' Utility Board, the Industrial

Customers of Northwest Utilities, Northwest and Intermountain Power Producers Coalition, and Staff of the Public Utility Commission have indicated that they do not oppose this motion. PGE has not received a response from the Oregon Department of Energy and Renewable Northwest.

Because the Commission workshop is scheduled for next Friday, PGE requests expedited consideration of this motion pursuant to OAR 860-001-0420(6).
