8	Pursuant to OAR 860-001-0420(6), Staff of the Public Utility Commission of Oregon		
9	(Staff) respectfully requests that Administrative Law Judge Moser review this motion to suspend		
10	the remainder of the procedural schedule in this docket with expedited consideration.		
11	By way of background, Staff circulated a notice of settlement to all parties in this docket		
12	for a settlement conference convening on May 29, 2018. Three of the seven parties to this		
13	docket attended the settlement conference, including PacifiCorp, Staff, and Oregon Citizens'		
14	Utility Board (CUB). After the settlement conference concluded, follow up settlement phone		
15	conferences were held to further discuss party positions.		
16	As a result of those discussions, PacifiCorp, Staff, and CUB (Stipulating Parties) have		
17	reached a settlement in principle resolving all issues in this proceeding. However, Staff and		
18	Intervenor Reply Testimony is due this Friday, June 22, 2018, therefore, Staff requests expedited		
19	consideration of this motion to suspend the procedural schedule while the Stipulating Parties		
20	work to finalize and execute the stipulation, and draft testimony in support. The Stipulating		
21	Parties expect to file the stipulation and supporting testimony for Commission review no later		
22	than July 18, 2018.		
23	Pursuant to OAR 860-001-0420(2) and (6)(a), Staff has conferred with the parties to this		
24	docket by explaining Staff's intention to move to suspend the procedural schedule and by		
25	circulating a draft of this motion by email. Staff does not believe that a response time is		
26	necessary for this motion given that no parties have objected to the proposed motion. Staff		

1	respectfully requests that Judge Moser grant Staff's motion to suspend the procedural schedule in	
2	this docket.
