Pursuant to OAR 860-001-0420, the Alliance of Western Energy Consumers ("AWEC") moves for permission to appear telephonically at the hearing in the above-referenced docket scheduled for November 20, 2018. Because the hearing in this matter is scheduled for tomorrow afternoon, AWEC requests expedited consideration of this motion.

On November 14, 2018, the Administrative Hearings Division issued a ruling ("Ruling") in this docket denying a motion to waive the hearing, noting that the Commissioners intended to question certain witnesses. The Ruling stated that questions would be posed only to Portland General Electric Company and Commission Staff witnesses, and specified that "[o]ther parties do not need to make their witnesses available." AWEC still intends to participate in the hearing and, as noted in its cross-examination statement, to ask follow-up questions of any witnesses if necessary. However, because AWEC's witness is not required to attend the hearing, and due to competing demands of other business, AWEC respectfully requests that it be allowed to participate by phone. AWEC has contacted the other parties to this docket, but has not yet received responses with their position on AWEC's request. Nevertheless, AWEC does not
