Expedited Consideration Requested

Pursuant to OAR §§ 860-001-0420, 860-001-0090, and 860-001-0590, Portland General Electric Company (PGE) moves the Administrative Law Judge (ALJ) to postpone the prehearing conference in the above-captioned matter scheduled for December 27, 2018, so that parties will have an opportunity to review and discuss PGE's filing during the workshops planned for January 2019.
