10	On March 5, 2019, the Commission issued an order adopting Staff's recommendation to	
11	conduct an enhanced May update of avoided cost prices and to require utilities to provide	
12	enhanced public information related to interconnecting to their distribution and transmission	
13	systems. With respect to interconnection information, the Commission directed that "Staff	
14	should also present a final recommendation for enhanced public information about	
15	interconnection for consideration at our June 6, 2019 Public Meeting." ¹	
16	To the extent an order is necessary to move the date for Staff's presentation, Staff moves	
17	the Administrative Law Judge (ALJ) for an ordering moving the presentation from June 6, 2019,	
18	to June 18, 2019. On May 17, 2019, Staff notified parties by e-mail to the service list of its	
19	intention to request permission to move the presentation to June 18, 2019, and invited parties to	
20	notify Staff of an objection. No party objected.	
21	On May 17, 2019, Staff conducted a workshop at which it noted it would not be	
22	presenting its recommendation regarding interconnection at the June 6, 2019 public meeting but	
23	would be doing so at the subsequent June public meeting. On May 22, 2019, Staff sent an e-mail	
24	to the parties regarding their final opportunity to file comments regarding Staff's proposal	
25	regarding interconnection data:
