**STIPULATED MOTION TO
AMEND PROCEDURAL
SCHEDULE**

Pursuant to OAR 860-001-0420(2), Portland General Electric Company (PGE) moves to modify the procedural schedule in this proceeding, subject to Commissioner availability. PGE has contacted all parties to this docket regarding the proposed revision and no party objects.

On June 19, 2020, Administrative Law Judge (ALJ) Allwein issued a ruling granting Staff's motion to hold a workshop in Phase I of this proceeding on August 20, 2020 (June 19 Ruling). In Staff's motion, Staff also indicated that parties were continuing to look for additional dates that could work for all parties for the workshop. The purpose of identifying other possible dates is to keep this docket moving forward expeditiously. After conferring with all parties, we have found that parties are also available on August 7, 2020 as an alternative date for this workshop.

ALJ Allwein's June 19 Ruling also directed parties to provide a draft agenda for consideration one month prior to the workshop. If the workshop is moved from August 20, 2020 to August 7, 2020, we propose to submit an agenda for the workshop by July 17, 2020. The parties to this proceeding have conferred on this approach, and no party objects.

PGE respectfully requests to move the Phase I workshop from August 20, 2020 to August 7, 2020, subject to Commissioner availability.
