19	At the workshop, parties only raised concerns about the straw proposal deadline, resolved by	
20	extending the straw proposal due date. ¹ In addition, Staff corresponded with parties about	
21	opportunity to provide input or objections regarding the proposed schedule on January 22, and

23	PacifiCorp. and Staff received support for the proposed dates from PGE, CUB, NIPCC, AWEC,
