JOINT UTILITIES' MOTION TO CHANGE PROCEDURAL SCHEDULE

Pursuant to OAR 860-001-0420, Idaho Power Company, PacifiCorp, dba Pacific Power, and Portland General Electric Company (collectively, the Joint Utilities) request that the Administrative Law Judge (ALJ) change the procedural schedule in this matter as set forth below. On October 16, 2020, the ALJ issued a ruling requesting that the parties work together to reschedule the remaining procedural deadlines and submit a motion to change the procedural schedule.
