OAR 860-087-0020(2)(c) further 19 20 states that "[t]he schedule will be adopted by an administrative law judge and will provide an 21 opportunity for written comments by Commission staff and stakeholders, and reply comments by 22 the electric company." 23 Idaho Power Company (Idaho Power) filed its 2019 Transportation Electrification Plan 24 on November 1, 2019.
